## DESIGNER TERMS AND CONDITIONS

1. I have read and understood all the "Terms and Conditions". My filling up of the Registration Form at <https://globalspin.net/registration/> and entering of the required information/ details, uploading the asked documents and pressing the 'REGISTER' button therein signifies my acceptance to all the below "Terms and Conditions" in entirety and without any deviation.
2. I agree that participation is based upon review and approval by the Organizing Committee.
3. I agree to pay the 50% deposit Registration Fee and balance payment by date agreed with Organizer/ Co-Organizer. I acknowledge that failure to make the payment by the agreed due date may result in the removal of my line from WEAVE IN PEACE Show - WIPS.
4. I acknowledge that the Participation Fee and any other fee I pay is non-refundable. Participation includes a show slot with the standard stage, sound and lighting equipment. Allocation of the show slot is at the discretion of the Organizing Committee.
5. Models, Hair and Makeup Services will be provided by Organizers. If I intend to use my own model, I acknowledge that I must submit the request with model portfolio to the Show Director/ Show Coordinator for consideration by the Organizing Committee.
6. I agree to abide by established times for scheduled appointments, interviews, deadlines, briefing, rehearsals, fittings, special appearances and other matters relating to the show. I acknowledge that WIPS has the right to terminate my participation in the show for violation of this requirement.
7. I agree to provide WIPS the following documentation for consideration of this application at the same time of submission of the application.
  - a. A portfolio of garments or accessories created in the last 24 months.
  - b. A brief biography of the designer and label.
  - c. Images (photos or illustrations) of the proposed looks/pieces/garments for your WIPS runway presentation.
  - d. Copies of past press and/or tear sheets of media coverage.
  - e. High resolution professional photos.
8. I acknowledge that WIPS is authorized to use photos submitted with the application for any promotional purposes. WIPS reserves the right to use all images derived in any form during or from the event and to transform the same into any or all forms of media currently in existence or yet to be created.
9. I agree that by sending my materials for print and/or online advertisement with WIPS, I have granted WIPS the license to use for promotional purposes free of charge.
10. I acknowledge that I will have 1 assistant to ensure all garments are hung properly, taken care of, and to assist with dressing the models at WIPS.
11. I agree and acknowledge that I undertake to attend WIPS at my own expense. WIPS may be able to arrange special discounted airfare, hotel and freight services, for which I may be eligible at my own expense.
12. Rolling racks and hangers will be provided. Please inform WIPS of how many racks and hangers you will need by making a request to [Contactus@globalspin.net](mailto:Contactus@globalspin.net)
13. I agree to attend the mandatory scheduled fittings and rehearsal prior to the event, in which my designs will be present for the models.
14. I acknowledge that WIPS will not be held liable for personal losses or injuries to participants, models or affiliated personnel except where such loss or injury is due to gross negligence on the part of WIPS.

15. I agree to liaise in advance of the event with the assigned Production Assistant in respect of appropriate music for the show in which my designs will be showcased, and with the designated makeup and hair consultant regarding my desired makeup and hair.
16. I agree to keep all confidential information strictly confidential by using a reasonable degree of care and not disclose any confidential information I receive to any third party.
17. I acknowledge that WIPS reserves the right to either postpone or cancel any function of the entire event in its sole discretion, without any liability for loss incurred thereby. In this event, WIPS will refund all applicable fees.
18. I understand and accept that WIPS reserves the right to review all designs and garments at any time prior to presentation at the designer show to ensure quality and completion, and further have the right to remove any garment or design from presentation if it deems appropriate to do so.
19. I acknowledge that this agreement, along with any other document referred to here, is the entire agreement between the parties (the Designer Applicant and WIPS) and I have read and understood its terms and conditions. Any right, benefit or obligation due to me under this Agreement is not assignable without the prior written consent of WIPS.
20. The laws of the State of New Delhi shall be the applicable law of this Agreement.
21. By completing the application form, I undertake that all information and data provided are true and correct and agree to abide to all terms and conditions and the submission deadlines of the fashion show as stated by WIPS.

### **Nomination and Evaluation:**

1. Each applicant would be required to fill in a Self-Nomination form
2. Designers, bouquets, or businesses registered and based in India and Abroad can apply
3. Any organization/individual from textile/allied sector can apply
4. Self- nomination forms should be submitted online.
5. Information received will be treated confidential and not used for any purpose except for determining the winner of the awards
6. Incomplete questionnaire in any manner will disqualify a participant from participating
7. Right to permit participation is reserved with the Organizing Committee.
8. Nomination fee per category is INR. 10,000 Plus 18% GST
9. Under no circumstances the nomination fee will be refunded
